Response B: SITE VISIT DATE

SECTION C: AMENDMENTS

Amendment No. 1: Page 10, Paragraph 2.5.4, Special Conditions of Tender: Deadline and Place for Submission of Tenders

The whole paragraph is amended to read:

“Completed tender documents are to be enclosed in plain sealed envelopes, marked with the tender number and name and be deposited in the Tender Box at Kwale International Sugar Company Limited Liaison Office – Main Reception Ground Floor) so as to be received on or before Thursday, 23rd October, 2014 AT 10:00 A.M.”

Amendment No. 2: Page 9, Paragraph 2.1.7, Special Conditions of Tender:-Site Visit Date
